The Trust/Society/Non Profit Company shall comply with the provision of Section 139A(1)(ii) and (iii) of the Act within one month of the date of this order to obtain a Permanent Account Number and shall (ii)communicate the PAN to this office.

The Trust/ Society/Non Profit Company shall maintain a/cs regularly and shall get these audited in accordance with the provision of section 12A(b) of the Income Tax Act, 1961. Separate accounts in (iii) respect of each activity as specified in memorandum shall be maintained. A copy of such account shall be submitted to the Assessing Officer. A public notice of the action as canced on/to be carried or and the target group(s) (intended beneficiaries) shall be duly displayed at the Registered / Designated Office of the Organization.

Repairle stables maintained in compliance to section 11(4A) of the Income Tax Act 1961.

All the Public Money so received including for Corpus or contribution shall be routed through a Bank Account and such Bank Account Number shall be communicated to this office.

No change in the Trust Deed/ Memorandum of Association /instrument shall be effected without the approval of the jurisdictional High Court/ Appropriate Authority and it shall continue to serve the mail (v)object of the trust in future without any change.
